PRIVACY POLICY

This Privacy Policy describes how TTP Ltd (the "Company") collects, uses, processes, stores, discloses and protects personal information obtained from clients in the course of establishing and maintaining a business relationship. This Policy forms an integral part of the Client Services Agreement and should be read together with it. In the event of any inconsistency, the terms of the Client Services Agreement shall prevail.

The Company is a limited liability company incorporated in Seychelles, authorised and regulated by the Financial Services Authority of Seychelles. The Company is committed to safeguarding the confidentiality of personal information and processing such information in accordance with applicable laws, regulatory requirements and its contractual obligations to clients.

By submitting an application, opening an account, or otherwise using the Company's services, the Client acknowledges that personal information will be collected and processed in accordance with this Privacy Policy and the Client Services Agreement.

The Company collects personal information that is necessary to provide its services, establish and administer the Client's account, comply with legal and regulatory obligations, and manage its relationship with the Client. This includes personal information provided during the account opening process and throughout the business relationship, such as identification and contact details, date and place of birth, nationality, residential address, financial and economic information, employment and professional details, source of funds and source of wealth information, trading history, payment details, and any documentation required for know-your-client, due diligence and ongoing monitoring purposes. The Company may also collect information relating to the Client's use of its website and trading platforms, including technical and usage data such as IP addresses, device information, login records and activity logs.

In accordance with Applicable Regulations, the Company may monitor and record telephone calls, emails, messages and other communications with the Client, as well as activity on the Client's account, for regulatory compliance, crime prevention and detection, protection of the Company's systems, quality control and staff training. Such monitoring is carried out where required by law or justified by the Company's legitimate interests.

Personal information is processed strictly for legitimate purposes, including the provision of services under the Client Services Agreement, verification of the Client's identity, performance of anti-money laundering and counter-terrorist financing checks, administration and operation of the Client's account, execution and settlement of transactions, communication with the Client, compliance with legal and regulatory requirements, and the protection of the Company's rights and systems. The Company does not process personal information for purposes that are incompatible with those described above.

The Company may disclose personal information to third parties where this is necessary to provide its services or comply with legal or regulatory obligations. Such disclosures may include regulators, supervisory authorities, courts or law enforcement agencies, as well as banks, payment service providers, liquidity providers, IT and platform providers, compliance and identity

verification service providers, auditors, legal advisers and other professional advisers. The Company may also share information with business partners or suppliers to whom certain functions have been outsourced. Any disclosure is limited to what is necessary for the relevant purpose and subject to confidentiality obligations.

In order to provide services, personal information may be transferred to and processed by parties located outside Seychelles, including in jurisdictions that may not provide an equivalent level of data protection. Where such transfers occur, the Company takes reasonable steps to ensure that the confidentiality and security of personal information is maintained. By submitting personal information and entering into the Client Services Agreement, the Client acknowledges and consents to such transfers, storage and processing.

Personal information is retained for as long as necessary to fulfil the purposes for which it was collected, including compliance with record-keeping, regulatory and reporting obligations, resolution of disputes and enforcement of contractual rights. Records may be retained for a period required by Applicable Regulations even after the termination of the business relationship.

The Company implements appropriate technical and organisational measures to protect personal information against unauthorised access, loss, misuse, alteration or disclosure. While the Company takes reasonable steps to safeguard personal information, the Client acknowledges that no electronic transmission or storage system can be guaranteed to be completely secure.

Subject to Applicable Regulations, the Client may request access to personal information held by the Company, request correction of inaccurate or incomplete information, or request deletion of personal information where legally permissible. Requests may be refused or restricted where the Company is required to retain information to comply with legal or regulatory obligations. Any such requests should be submitted to support@ttpmarkets.com, as specified in the Client Services Agreement.

The Company may use cookies or similar technologies on its website and platforms to ensure proper functionality, monitor usage and improve services. Disabling cookies may affect the performance or availability of certain features.

The Company reserves the right to amend this Privacy Policy at any time. Any updates will be published on the Company's website and, where appropriate, communicated to Clients. Continued use of the Company's services following such updates constitutes acceptance of the revised Privacy Policy.
